

This project has been implemented for $\underline{18}$ months to assist $\underline{3,021}$ beneficiaries in the $\underline{3}$ barangays of Salog, San Jose, Tulang in the municipality of Getafe, Bohol. About 51% (1,533) of the beneficiaries are women.

The project also captured the following key contributions and impact (desired/undesired effects) on women:

The STRIDE project concept clearly anchors on the resiliency of the inhabitants in terms of addressing disaster-related issue of which women are vulnerable and are over-burden every time calamities will strike. All throughout the project implementation, the women actively participated in all facets of the projects.

Specifically, the following are the key contributions and impact on women:

- 1. Empowerment of women through the series of capacity building activities done of which 54% of the participants were women.
- 2. At the organizational level, many women are now holding key positions. This clearly manifests that more women are highly respected and recognized. And STRIDE project is very much conscious of its vital role in the furtherance of gender development. In fact, major decisions were being participated by women as regards to project implementation.

At the community level, the project also helped in contributing to the following changes (expected and unexpected):

- 1. The capacity building activities greatly contributed at the community level. After the training, some of the participants shared the changes of their lifestyle in addressing DRRM issues (e.g. stopped burning plastics in their backyard, segregation of garbage, etc.)
- 2. Clearer understanding of the Barangay Officials on the importance of DRRM Plans and the role of the BDRRMCs.
- 3. Concrete allocation of DRRM budget based on their realistic BDRRM Plans.

Some of the barangay officials admitted that their BDRRMC was not properly organized as they only appointed personnel just to fill up the structure for compliance with the

- requirements of DILG. Some participants realized that they have also a big part in addressing any concerns related to climate change especially in responding emergency situation.

Challenges Encountered

As an implementer, there were some issues and concerns encountered during the start of the project such as lack of support of some barangay officials in Barangay Tulang, the demand for livelihood project before the project ends, among others. However, the issues and concerns were mitigated by consciously explaining to the partner POs and barangay councils the objectives of the projects and by being transparent and participatory in the project implementation. As a result, all the three LGUs were being supportive in the project implementation. In fact, they willingly provided their local counterparts in the course of the project implementation. Likewise, since all the POs were already registered with the Department of Labor and Employment (DOLE), PROCESS-Bohol encouraged them to participate in the Bottom Up Budgeting (BUB) related activities. DOLE is providing livelihood assistance through BUB.

PROCESS-Bohol also facilitated the POs to access livelihood projects in other government agencies such as DENR and BFAR. To date, the Tulang Guso Farmers' Association of barangay Tulang as well as the Initiator for Sustainable Development (ISDA) and San Jose Fisherfolks Association (SAJOFA) both from San Jose, Getafe are partners of Department of Environmental and Natural Resources (DENR) for their National Greening Program of which the 3 POs were already financially benefited from the said program.

Lessons Learned

Throughout the entire project implementation of STRIDE project, the following lessons were learned:

- a) Partnership and collaboration with various agencies such as DILG, DENR and DOLE including LGUs and POs made the project implementation smooth-sailing and successful;
- b) The importance of concrete and need-based DRRM Plan with corresponding budget which used to be just an attribution and for compliance purposes for the release of LGU budget
- c) Increased awareness of communities on DRRM
- d) Active involvement of women in the project implementation and the recognition of their roles and functions boost the morale of women. They are now empowered!
- e) Environment-friendly livelihood helped mitigate the issue on climate change.
- f) PO members and officers gained knowledge and skills on leadership development and the values of group efforts and self-reliance

Other Activities

The project staff attended and participated the "National Arbor Day Celebration" last June 25, 2015 of which the stakeholders planted mangroves at the coastal areas of Salog, Tulang and

San Jose, Getafe as well as in the joint meeting of Municipal Peace and Order Council (MPOC), Municipal Development Council and Municipal Disaster Risk Reduction Management Council.

Likewise, the Project Coordinator, Mr. Joel Gubot, participated in the Project Proposal Writing Workshop last March 16, 2016 in Talibon, Bohol

Sustainability

The sustainability of the project depends primarily on the willingness and capacity of the partner POs and barangay council to take on the responsibilities of sustaining the project.

All the 4 POs are already registered with the Department of Labor and Employment. As such, these will serve as one of the mechanisms in sustaining their respective organizations.

As far as the Sangguniang Barangay of the 3 assisted barangay is concerned, there is a high percentage of assurance for the sustainability because of the existing policies and guidelines of the government which are mandatory for the LGUs to implement DRRM-CCA related project with corresponding budget.

The established good working relationship between the POs and the LGUs for partnership and collaboration of any activities to be conducted at the community level gives assurance for the sustainability of the project.

Impact on Gender and Development

The STRIDE project concept clearly anchors on the resiliency of the inhabitants in terms of addressing disaster-related issue of which women are vulnerable and are over-burden every time calamities will strike. All throughout the project implementation, the women actively participated in all facets of the projects. In fact, two (2) of the four (4) partner people's organizations are mostly dominated by women namely the *Malungtarung Mag-uuma sa Salog* (MAMSA) in Barangay Salog, Getafe and the *Initiator for Sustainable Development Association* (ISDA) in Barangay San Jose, Getafe. Major decision are being participated by women as regards to project implementation.

Like for instance in MAMSA greening project in the upland area, most of the forest guards or "Bantay Lasang" are women. Women also actively participated in the establishment of windbreak thru mangrove plantation in Barangay Tulang, Salog and San Jose.

At the organizational level, many women are now holding key positions. This clearly manifests that more women are highly respected and recognized. And STRIDE project is very much conscious of its vital role in the furtherance of gender development.

Impact on Children

The establishment of windbreaks indirectly has positive effects to the children as it will protect them from possible disaster and calamities in the future. The project sites are along the coastal areas, thus, prone to storm surge and tsunamis. With the plantation of mangroves in the coastal areas, this will protect the children from any untoward incidents such as storm surge and tsunamis.

Impact on the Environment

The approximately 5.5 kilometer natural windbreak established with more than 55 hectares of mangroves plantation greatly contributed a big impact to the environment. It will protect them from possible disaster and calamities in the future. The project sites are along the coastal areas, thus, prone to storm surge and tsunamis.

The plantation of mangroves in the coastal areas protects the communities from any untoward incidents such as storm surge and tsunamis. Likewise, this will provide food security of the people since the habitat of marine resources are protected through the existence of the 4 fisherfolk organizations.

He is the President of Malungtarung Mag-uuma sa Salog (MAMSA) Salog, Getafe, Bohol. Mr. Torremocha was really happy upon delivering his message during the conduct of Basic Life Support and First Aid Training which is the first time that he participated this kind of training ("Nalipay gyud ko ug daku nga nakaapil ko niining seminar. First time nako naka-apil ug training nga aduna gyud practicum"). This is also the reason why I am very enthusiastic in doing my responsibilities as a president in our association because of this project ("Usa kini sa mga hinungdan nganong nagmadasigon ako sa pag-alagad isip President sa among grupo tungod niining proyektoha). Hoping that the knowledge they learned from this training with his colleague will be applied not only for the organization but also to our individual families ("Manghinaut ko nga ang tanan nga atong makat-unan sa training atong mahimuslan dili lamang sa atong association kon dili ma-apply usab sa atong tagsa-tagsa ka pamilya").

Lydia Villas High School Teacher Tulang, Getafe

She is the Assistant Secretary of Tulang Guso Farmers Association (TUGUFA) and a public school teacher of Tulang Elementary School, Barangay Tulang, Getafe, Bohol. The new elected officer of the association expressed her insights during the conduct of Barangay Disaster Preparedness and Emergency Response Training while she delivered her message about the training and the project. "Isip usa ka bag-ong napili nga opisyal sa among asosasyon, daku kaayo ko ug pasalamat sa nagdumala sa maong seminar ang NGO nga PROCESS-Bohol ug ang naghatag niini ug pondo mao ang PACAP, tungod kay naghatag kini ug tabang kanamo dili sa pinansyal nga tabang kon dili sa mga butang nga importante pa kay sa kwarta-mao ang knowledge nga gikan sa nagkadaiyang mga seminars." She expressed thanks and gratitude to the non-government organization (PROCESS-Bohol) the implementer of the project and to PACAP as the funding agency for bringing them this project to their barangay that contributes very important thing that even money cannot buythe knowledge that they learn from different seminars. "Dugang pa niini, nalipay jud ko kay kining akong mga nakat-unan gikan sa tanan natong training, ako jud mapa-ambit sa akong mga estudyante sa among eskwelahan. She is the Treasurer of Malungtarung Mag-uuma sa Salog (MAMSA) Salog, Getafe, Bohol. Mrs. Torrejos was really happy because of the trainings and seminars that she participated from STRIDE Project. I learned a lot and gained some learning and insights and experiences shared. ("Malipayon gyud ko tungod kay daghan nako ug naapilan nga mga seminar nga gidala sa STRIDE project, unya daghan kaayo ko ug nakat-onan nga kahibalo ug mga experiences") Today, I already applied all the knowledge I've learned from the seminars like I stopped using commercial fertilizers in my farm because it is harmful to our environment as well as to our health ("Karon, ako najud gi-apply ang kahibalo nga akong nakuha gikan sa mga seminars sama sa; wala na ko mogamit ug mga abuno nga commercial sa akong panguma kay daku diay kaayo ni nga kadaut sa kalikupan ingon man sa atong panglawas").

In addition, I've learned a lot on about disaster preparedness. We already know what to do on an emergency, how to rescue and in case there is an accident, i already know how do first aid. ("Dugang pa, alisto na me kon ugaling adunay kalamidad nga moabot sa among dapit, kahibalo na me unsay buhaton ug lain pa kahibalo nako unsaon pag-rescue ug paghimo ug first aid ug ugaling adunay mga ma-aksidente").

He is the Secretary of the San Jose Fisherfolks Association (SAJOFA) San Jose, Getafe, Bohol. According to him, he is very thankful that the STRIDE project arrived in their place because the project teach them on how to being prepared in times of calamity. Besides, he is very thankful of the project because without the assigned staff, their organization cannot acquired legal identity or certification from DOLE ("Nagpasalamat ko sa STRIDE Project nga miabot sa among lugar tungod kay ang proyekto nagtudlo kanamo nga unsaon pagpangandam kon adunay kalamidad nga moabot sa ilang lugar. Rosalina Turtuga Member, TUGUFA Tulang, Getafe

She is a member of Tulang Guso Farmers' Association (TUGUFA) Tulang, Getafe, Bohol. Being a member, she is very happy to share her testimony on how significant is the STRIDE project in their place. She said that because of the trainings and seminars, our vision and direction of life was changed, compared before. We do not have concern about our environment. Even the our barangay officials, they don't care. But now, because of this project, we realized that everyone has a responsibility. ("Pinaagi sa project sa mga seminar nga gihatag niini, lahi na sa una ang among panglantaw, ka sa una, dili ra mi magpakabana ug bisan ang mga opisyal dili kaayo. Pero paghimo ani nga project daghan mi ug na amgohan"). Being concern to each other is very important as well as being a good leader in the community to gain the trust and unity of our people in addressing the effects of calamity that may strike in our place. ("Kinahanglan diay ang pagpakabana, kinahangan ang maayo nga leader sa komunidad. Kinahangan usab ang pagkahiusa ug pagtinabangay para malikayan ang posibleng kadaut sa kalamidad").

For the environment, we continue to support our project through mangrove planting because we understand that it really contribute a big help it terms of protecting the lives of our people in times of calamity like tsunami or storm surge. ("Sa environment, continue ang among pagpananum ug bakhaw aron makatabang kini kon ugaling adunay kalamidad sama sa storm surge o tsunami"). And in terms of health, we've learn from the project how to rescue in case there is an emergency happen ("Ug sa health sa gitudluan mi unsaon pagrescue ug dunay emergency").

Promotional Activities

The promotional activities that the implementer done to promote and inform the general public was the distribution of flyers during trainings conducted in the 3 barangays. The said materials was from Bohol Island State University and the office of the Regional Climate Change Center through Mr. Jose T. Travero.
